### **Approval of Minutes**

Mayor Hicks asked if there were any additions or corrections to the minutes of the regular City Council meeting on April 4, 2011. Hearing none, the minutes were approved as presented.

#### Public Hearing—City Code Amendment Chapters 150 & 155: Accessory Buildings and Fences

Hinzman introduced the item and noted that the changes are clarification among two sections of the code.

# Second Reading/Ordinance Amendment—City Code Amendment Chapters 150 & 155: Accessory Buildings and Fences

Moved by Councilmember Alongi, seconded by Councilmember Schultz to approve the ordinance amendment as presented.

7 Ayes; Nays, none.

# Public Hearing on Ordinance Amendment—False Alarm Registration

Osberg introduced the item and provided background on the proposed ordinance.

Mayor Hicks opened the public hearing at 7:07 p.m.

Tony Berens, 209 East 2<sup>nd</sup> Street, inquired what the fee will be when the cost of the registration outstrips the revenue. Mayor Hicks noted that it is not the Council's intent to consider a registration fee for this ordinance. The proposed penalty fees will be considered at the May 2 Council meeting.

Hearing no further comments, Mayor Hicks closed the public hearing at 7:08 p.m.

#### Second Reading/Ordinance Amendment—False Alarm Registration

There was discussion about the purpose of registering an alarm system. Osberg and Schnell noted that registration provides the most accurate information to public safety. It was also noted that false alarms consume limited public safety resources and there is currently no incentive to address faulty alarm systems. There was discussion about the kinds of alarm systems that would be required to register; Schnell noted that monitored systems would register. There was also discussion over what public safety response occurs in the case of a false alarm; it was noted that alarms are considered "in progress" emergencies, so two squads and/or fire personnel are dispatched to respond to the alarm.

Moved by Councilmember Alongi, seconded by Councilmember Nelson to approve the ordinance amendment as presented.

7 Ayes; Nays, none.

#### **Vacant Housing Registration Ordinance**

Osberg introduced the item and noted that staff would support canceling the public hearing and sending this item back to committee for further discussion.

Councilmember Hollenbeck, chair of the Administrative Committee, noted that the version as written has some unintended consequences and she would support review of what tools are currently in place to better recover staff costs related to vacant housing issues.

Councilmember Slavik noted that there were legitimate properties that drove this discussion and it's a community issue to try to address those poorly maintained properties.

Councilmember Schultz noted that she supports continued discussion about addressing problem properties. Mayor Hicks concurred, and noted that there may be existing language that would permit the City to address problem properties.

Moved by Councilmember Hollenbeck, seconded by Councilmember Slavik to cancel the public hearing and second reading and refer this item back to committee for future further discussion. 7 Ayes; Nays, none.

#### Update—Senior Center Relocation to Tilden

Superintendent Collins provided background on a proposal to realign some existing services, including relocating the senior center to the remodeled Tilden. Councilmembers Nelson and Slavik, members of the Joint Powers Board, spoke in support of the concept as outlined.

Moved by Councilmember Nelson, seconded by Councilmember Balsanek to approve the concept as proposed.

# Update—LeDuc Historic Estate

Jessica Bierbauer from LeDuc provided an overview of proposed events and activities scheduled for the LeDuc in 2011. The Council thanked Ms. Bierbauer for the information.

# **Hastings Hockey Booster Training Facility**

Osberg introduced the item and outlined some of the elements of a proposed agreement, including proof of financial viability before the project can commence and some allowance for "city" hours at the facility. Osberg noted that the Boosters are requesting further consideration about being able to bid the project as well as consideration of not having to comply with the Council's prevailing wage policy.

Mark Chorney from the Hastings Hockey Boosters was present.

There was discussion about both of the questions raised by the boosters. The Council resolution of July 2010, supporting the project in concept, included both provisions. There was discussion about the price of the project, use of in-kind labor to reduce the cost of the project, and the impact of the prevailing wage policy.

Moved by Councilmember Nelson, seconded by Councilmember Schultz to support the proposed agreement concepts and reaffirming that the City will oversee the bid process and that the City's prevailing wage policy must be complied with.
