ORDINANCE NO. 2012- , THIRD SERIES

A Charter Ordinance of the City of Hastings  
Amending Precinct and Ward Boundaries

BE IT ORDANED BY THE CITY COUNCIL OF THE CITY OF HASTINGS:

HASTINGS CITY CHARTER CHAPTER 1, SECTION 1.03 IS AMENDED BY ADDING THE FOLLOWING (new language is underlined, strikethrough language is deleted):

SECTION 1.03 WARD BOUNDARIES. The City is, and shall be divided into four (4) wards. The boundaries of said wards shall be as follows, until changed pursuant to this charter, or by operation of law.

**Ward 1** shall consist of the area within the city limits lying east of a line beginning at the intersection of the north boundary of the city in Denmark Township, Washington County, and the Washington - Dakota County line on the Mississippi River, proceeding downstream to Trunk Highway 61; ~~then south along Vermillion Street/Trunk Highway 61 to 15<sup>th</sup> Street East; then East along 15<sup>th</sup> Street East to Tyler Street; then south along Tyler Street to 18<sup>th</sup> Street; then west along 18<sup>th</sup> Street to Vermillion Street/Trunk Highway 61;~~ then proceeding south on Vermillion Street/Trunk Highway 61 to its intersection with Highway 316/Red Wing Boulevard; proceed south along Highway 316/Red Wing Boulevard; proceed West on Tiffany Drive to Cari Park Lane 33<sup>rd</sup> Street and south on the east portion of Tiffany Drive to 36<sup>th</sup> Street East, proceeding west to Vermillion Street/Trunk Highway 61; proceeding south on Vermillion Street/Trunk Highway 61; as bounded on the west side of Ward 4; encompassing all within the city limits.

**Ward 2** shall consist of the area within the city limits lying west of the Washington - Dakota County boundary on the Mississippi River, proceeding downstream to Trunk Highway 61, and lying west of Trunk Highway 61 from the County boundary to 14<sup>th</sup> Street West; and lying north of a line along ~~12<sup>th</sup>~~ 14<sup>th</sup> Street West from Vermillion Street/Trunk Highway 61 to ~~Pine Street~~ Lyn Way; then proceeding north on ~~Pine Street~~ Lyn Way to Trunk Highway 55; then proceeding west on Trunk Highway 55 to the west boundary of the city limits.

**Ward 3** shall be bounded on the north by the south boundary line of Ward 2 described above; on the west by the west boundary of the city limits; on the south by a line along ~~O'Connell Drive~~ 15<sup>th</sup> Street West from the west city limits ~~north east~~ to 14<sup>th</sup> Street Westview Drive; then proceeding ~~west south~~ on Westview Drive 14<sup>th</sup> Street to ~~General Sieben~~ Southview Drive; then proceeding ~~south west~~ on ~~General Sieben~~ Southview Drive to Tierney Pleasant Drive; then proceeding east along the Vermillion River ~~on Tierney~~

~~Drive to Brittany Road; then proceeding north along Brittany Road to 14<sup>th</sup> Street West; then proceeding east on 14<sup>th</sup> Street West to Westview Drive; then proceeding south on Westview Drive to Southview Drive; then proceeding east on Southview Drive to Pine Street; then proceeding south on Pine Street to County Road 47/Vermillion Road; then proceeding east on County Road 47/Vermillion Road to Trunk Highway 61/Vermillion Street; then proceeding north on Trunk Highway 61/Vermillion Street to 18<sup>th</sup> Street East; then proceeding east on 18<sup>th</sup> Street East to Tyler Street; then proceeding north on Tyler Street to 15<sup>th</sup> Street East; then proceeding west on 15<sup>th</sup> Street East to Trunk Highway 61/Vermillion Street; then proceeding north on Trunk Highway 61/Vermillion Street to the south boundary of Ward 2 as described above.~~

**Ward 4** shall be bounded on the north by the south boundary of Ward 3 as described above; on the west by the west boundary of the city limits from O'Connell Drive; to the south by the south boundary of the city limits, encompassing the area lying within the city limits lying south of County Highway 47, proceeding to the east along the south boundary of the city limits to Highway 61/Vermillion Street; and on the east by a line beginning at the intersection of the south boundary of the city limits and Highway 61/Vermillion Street, then proceeding north on Highway 61/Vermillion Street to 36<sup>th</sup> Street East; proceeding east along 36<sup>th</sup> Street East to the east intersection with Tiffany Drive and then proceeding north along Tiffany Drive to Cari Park Lane; then proceeding east along Cari Park Lane to Tiffany Drive; then proceeding east along Tiffany Drive to Highway 316/Red Wing Boulevard, and then proceeding north and west along Highway 316/Red Wing Boulevard, being the west boundary of Ward 1 as described above, and terminating at the southeast boundary of Ward 3.

This Ordinance shall be effective upon its passage and publication.
