Chairman Simacek called the meeting to order at 6:00 p.m.

Members Present: Council members Trautmann, Nesbitt, Werner, Plan, and Karnick, Planning Commission members present - Simacek, Murphy, Conzemius, Wendler, Reuter, and Martin.

Chairman Simacek indicated that some of the issues discussed at the last meeting involved establishing a standard lot size, lot width, street width, and that there had been discussion regarding neighborhood consent. The Committee discussed the various standards that had been brought up at the last meeting. Councilman Karnick suggested that the R-2 be split up into sub-zones to protect some of the old homes from being totally surrounded by conversions. After much discussion, the following standards were organized for further research by the City Staff:

30 foot traveled roadway 9,000 square foot lot size

10 foot side setback

15 foot side setback on a corner lot

35 foot rear setback

25 foot front setback

25 foot height restriction (new construction only) 1,600 square foot minimum house size for conversion

The City Staff was asked to research the percentage of lots in the R-2 District that would be able to meet these requirements, to check whether the 1,600 square foot size requirement was appropriate with the Building Inspector, and to report on the minimum unit size that could be built under the Building Code. The next Committee meeting was scheduled for 6:30 p.m. on August 22, 1983, at the City Council Chambers.

The meeting was adjourned at approximately 7:00 p.m.

Dear Gary,

At its August 3, 1983 meeting, the County Board of Commissioners considered the action taken by the Hastings City Council regarding the construction of a communication tower at the Government Center site. As the attached resolution indicates, the County Board accepted the condition that the tower be setback a distance equal to or greater than its height. However, the condition that the County own the tower was found to be unacceptable, as such a condition is not consistent with the purpose for which the County initially gave its concept approval.

It is felt by the County that a lease agreement with Chicago and Northwestern, rather than ownership of the tower, best serves the County's interests and meets the County's future needs. It is also very likely that provisions can be incorporated into the lease agreement that will address the concerns expressed by the City Council as they relate to responsibility for correcting any unforeseen problems that may occur in the future with the tower. Toward this end, a provision similar to that which is attached could, we feel, be incorporated into the lease agreement between Dakota County and Chicago-Northwestern for the construction of the tower.

I hope this approach proposed by the County Board meets with the approval of the City Council at its meeting on August 15. If you have any questions, please feel free to call at anytime.

Dear Mr. Brown:

Following last Mondays Council Meeting concerning the condominium proposal, I am led to believe that there are basically two problems with the rezoning. First, the effect on Lake Rebecca and second, the lift station.

In talking with the owner of the land and my client, Mr. Erickson, I have obtained their agreement to execute a flowage easement to the City over that property lying below 691 feet elevation. I have also asked the City Attorney to draft such a document for signature by Mr. Reuter and Mr. Erickson. The second part of the Lake Rebecca objection is that the land must be stabilized. It is the intention of Mr. Erickson to cover the existing material with soil which will support grass or other vegetation which will in effect clean up that area not occupied by a building. It will also stabilize the bank and prevent erosion. This work would be accomplished as part of the condominium construction and specifics can be set out in the site plan.

The second issue is the sewer lift station. I understand that the City has already obtained information concerning a lift station in the general vicinity of this subject property. I would ask that the City make that information available to Mr. Erickson so that he may adopt a plan for either a privately owned lift station serving his condominium or a lift station to be dedicated to the public which would serve not only his project, but the other unserved residences in the area. The cost of the private lift station would be borne entirely by Mr. Erickson. If the project would be dedicated, I propose that the condominium units each be treated as one participant and each of the other housing units served be treated as one unit, and the cost of the entire project be pro-rated among all of the served residential units. For example, if there are twelve condominium units and three other houses served, or a total of 15 units, Mr. Erickson would pay 12/15ths of the entire cost of the project. The City may assess or do whatever they like regarding the payment of the balance of the construction costs. Mr. Erickson will agree to either a publicly or privately owned lift station and will build the system to the specifications reasonably required by the City Engineer.

It is my hope that resolution of the two problems stated above will enable this matter to be reintroduced at the earliest possible time for reconsideration by the City Council. As Mr. Erickson indicated it is important to move ahead rather promptly with this project because of the favorable construction costs, interest rates and market for this kind of development. Your assistance in this matter is greatly appreciated.



Per your discussion at the August 1 council meeting, attached is a rewrite of subdivision 7 regarding the use of barbeques. Our recommendation is to prohibit the use of igniting fluids on apartment decks. The new subdivision reads as follows:

"The use of any igniting fluids is prohibited to kindle or maintain any open flame in barbeques on any balcony or patio which is attached to, or within 15 feet of, any townhouse, condominium or apartment building in which there are two or more separate living units on more than one level unless the separate living units each has its own private means of ingress and egress or unless the entire building and patio or balcony is constructed of non-combustible material such as concrete or masonry."

I strongly urge you to include this subdivision in the ordinance's 3rd reading.

AN ORDINANCE ADOPTING THE MINNESOTA UNIFORM FIRE CODE 1982 EDITION

ORDINANCE NO.

An ordinance adopting the Minnesota Uniform Fire Code and prescribing regulations governing provisions hazardous to life and property from fire or explosion, providing for the issuance of permits for hazardous uses or operations, establishing a Bureau of Fire Prevention and providing offices therefore and defining their powers and duties, imposing a penalty for violation and repealing Ordinance No. 40, Second Series, effective date April 5, 1976.

The City Council of the City of Hastings does ordain as follows:

Subd. 1 - ADOPTION OF THE MINNESOTA UNIFORM FIRE CODE.

It is hereby adopted by the City of Hastings for the purpose of prescribing regulations governing conditions hazardous to life and property from fire or explosion, that certain code known as the Minnesota Uniform Fire Code, being particularly the 1982 Edition thereof and the whole thereof save and except such portions as are hereinafter deleted, modified or amended by Subdivision 6 of this Ordinance of which Code one copy has been and is now filed in the office of the Clerk of the City of Hastings, and the same is hereby adopted and incorporated as fully as if set out at length herein.

Subd. 2 - ESTABLISHMENT AND DUTIES OF THE BUREAU OF FIRE PREVENTION.

- (a) The Minnesota Uniform Fire Code shall be enforced by the Bureau of Fire Prevention in the Fire Department of the City of Hastings which is hereby established and which shall be operated under the supervision of the Chief of the Fire Department.
- (b) The Fire Marshal in charge of the Bureau of Fire Prevention shall be appointed by the Hastings City Council on the basis of examination to determine his qualifications.
- (c) The Chief of the Fire Department may detail such members of the Fire Department as inspectors as shall from time to time be necessary. The Chief of the Fire Department shall recommend to the Hastings City Council the employment of technical inspectors, who, when such authorization is made, shall be selected through an examination to determine their fitness for the position. The examination shall be open to members and non-members of the Fire Department, and appointments made after examination shall be for an indefinite term with removal only for cause.

- (a) Whenever the word "jurisdiction" is used in the Minnesota Uniform Fire Code, it shall be held to mean the City of Hastings.
- (b) Whenever the words "Chief of the Bureau of Fire Prevention" are used they shall be held to mean "Fire Marshal."
- (c) Whenever the term "corporation counsel" is used in the Minnesota Uniform Fire Code, it shall be held to mean the attorney for the City of Hastings.
 - Subd. 4 ESTABLISHMENT OF LIMITS OF DISTRICTS IN WHICH STORAGE OF FLAMMABLE OR COMBUSTIBLE LIQUIDS IN OUTSIDE ABOVE GROUND TANKS IS PROHIBITED.

The storage of flammable or combustible liquids in outside above ground tanks is prohibited within the entire City of Hastings.

- Subd. 5 ESTABLISHMENT OF LIMITS IN WHICH BULK STORAGE OF LIQUIFIED PETROLEUM GASES IS TO BE RESTRICTED.
- (a) Liquified petroleum gases may be stored in industrial parks for uses by industry located therein, but any such use shall comply with the following: Said storage facility shall be diked, mounded, buried, or in the alternative protected with at least a one hour fire retardant material with the approval of the Fire Chief or his authorized representative. Any storage facilities that are mounded or buried shall be coated with an approved coating and shall have devices installed on said facility so that the tank or tanks can be tested periodically for corrosion and durability.
- (b) Liquified petroleum gases may not be stored in any area other than industrial parks (as provided by the preceding subparagraph) except that in non-dense residential areas where natural gas is not available, with approval of the Fire Chief or his designate, liquified petroleum gas storage may be used as is necessary to service a residence or commercial operation. Under no circumstances may liquified petroleum gases be stored in densely populated residential areas. Whenever allowed in sparsely populated residential areas because of the unavailability of natural gas, said storage facility shall be diked, mounded, buried or protected with at least one hour fire retardant material with the approval of the Fire Chief or his authorized representative. Any storage facilities that are mounded or buried shall be coated with an approved coating and shall have devices installed on them so the tank or tanks can be tested periodically for corrosion and durability.
- (c) Temporary use of liquified petroleum as an energy source during construction shall be allowed only when approved by the Fire Chief and then in accordance with such restrictions as may be imposed by the Fire Chief or his representative to assure safe operation.
 - Subd. 6 AMENDMENTS MADE IN THE MINNESOTA UNIFORM FIRE CODE.
- (a) It is unlawful to park any vehicle or to locate any obstruction in an area designated as a fire lane, whether said fire lane is adjacent to a public or private structure or property.

- (b) The Chief of the Fire Department or his representative may review all building plans, except plans for single or two family residences to assure compliance with the provisions of the Minnesota Uniform Fire Code and he shall note any violations discovered in connection with said proposed structures to such persons as may be charged with the responsibility for review of said plans.
- (c) Section 10.402(c) of the Minnesota Uniform Fire Code shall be amended to read as follows:

Identification. When required by the Fire Chief, one of the two following signs shall be displayed permanently near or on each required fire door, in letters not less than one (1) inch high:

FIRE DOOR DO NOT OBSTRUCT

or

FIRE DOOR KEEP CLOSED

- (d) Article 4 of the Uniform Fire Code, 1982 Edition, titled "Permits and Certificates" is adopted in its entirety and incorporated as fully as if set out herein.
- (e) Each permit issued by the Fire Department, pursuant to the Minnesota Uniform Fire Code, shall be issued for a one year period unless otherwise provided in this subdivision. The yearly permit fee for said permit shall be \$20.00, provided, however, that if more than one permit is required for the establishment, the maximum permit fee shall be \$30.00 per year. Further provided that tank installation permits shall be valid until revoked by the Fire Chief or his designee and the permit fee shall be \$25.00 per installation, (not per tank). Permits issued for a period of less than ten days shall require a fee of \$10.00. Permit fees may be reviewed and revised by the council, by resolution, from time to time. until otherwise directed by the council by resolution, the permit year shall be the calendar year. Pro-rata adjustments, on a monthly basis, shall be made for permits for less than one full year. Except for tank installation permits and "short term" permits for less than ten days, all permits shall expire on the last day of December of each calendar year. The Chief of the Fire Department shall establish procedures and forms to carry out the intent of this subdivision.
- (f) The Chief and members of the Fire Prevention Bureau shall have the powers of a police officer in performing their duties under this Code.

Subd. 7 - ESTABLISHMENT OF RESTRICTIONS ON THE USE OF BARBEQUES.

The use of any igniting fluids is prohibited to kindle or maintain any open flame in barbeques on any balcony or patio which is attached to, or within 15 feet of, any townhouse, condominium or apartment building in which there are two or more separate living units on more than one level unless the separate living units each has its own private means of ingress

and egress or unless the entire building and patio or balcony is constructed of non-combustible material such as concrete or masonry.

Subd. 8 - NEW MATERIALS, PROCESSES OR OCCUPANCIES WHICH MAY REQUIRE PERMITS.

The City Administrator, the Chief and the Chief of the Bureau of Fire Prevention shall act as a committee to determine and specify, and for giving affected persons an opportunity to be heard, any new materials, processes or occupancies for which permits are required in addition to those now enumerated in said Code. The Chief of the Bureau of Fire Prevention shall post such list in a conspicuous place in his office, and distribute copies thereof to interested persons.

Subd. 9 - ESTABLISHMENT OF LIMITS OF DISTRICTS IN WHICH STORAGE OF EXPLOSIVES AND BLASTING AGENTS IS TO BE PROHITIBED.

It is the intent of this section to prohibit storage of explosive and blasting agents in the City and to require that any such explosive and blasting agents be removed from the City for storage.

Subd. 10 - APPEALS.

Whenever the Chief shall disapprove an application or refuse to grant a permit applied for, or when it is claimed that the provisions of the Code do not apply or that the true intent and meaning of the Code have been misconstrued or wrongly interpreted, the applicant may appeal from the decision of the Chief to the Board of Appeals established pursuant to the State Building Code and a provision of the City Code regulating the erection, construction, enlargement, alteration, repair, moving, removal, demolition, conversion, occupancy, equipment, use, height, area, and maintenance of all buildings and/or structures in the city.

Subd. 11 - PENALTIES.

- Any person who shall violate any of the provisions of this Code hereby adopted or fail to comply therewith, or shall violate or fail to comply with any order made thereunder, or who shall build in violation of any detailed statement of specifications or plans submitted and approved thereunder, or any certificate or permits issued thereunder, and from which no appeal has been taken, or who shall fail to comply with such an order as affirmed or modified by the Board of Appeals or by a court of competent jurisdiction, within the time fixed herein, shall severally for each and every violation and non-compliance, respectively, be guilty of a misdemeanor, punishable by a fine of not more than \$500 or by imprisonment for not more than 90 days or both. The imposition of one penalty for any violation shall not excuse the violation or permit it to continue; and all such persons shall be required to correct or remedy such violation or defects within a reasonable time; and when not otherwise specified, each day that prohibited conditions are maintained shall constitute a separate offense.
- (b) The application of the above penalty shall not be held to prevent the enforced removal of prohibited conditions.

Subd. 12 ~ VALIDITY.

The Hastings City Council hereby declares that should any section, paragraph, sentence or word of this ordinance or of the Code hereby adopted be declared for any reason to be invalid, it is the intent of the Hastings City Council that it would have passed all other portions of this ordinance independent of any such portion as may be declared invalid.

Subd. 13 - DATE OF EFFECT.

This ordinance shall take effect upon its passage and publication.

Attached please find a letter from Brad G. Moore, Chairman of the Suburban Rate Authority, pertaining to an assessment of \$736.20 to the City of Hastings for the operation of the Suburban Rate Authority.

The City Administrator attended the meeting in which this assessment was discussed. The City, through its membership, and because of its involvement with Minnegasco and Northern States Power, has received significant benefits from the fact that the Suburban Rate Authority has been a watch dog for all rate increases for these various utilities. Furthermore, they would get involved with a dispute if the City felt that the United Telephone Company were charging excessive rates.

As indicated in the letter, the original funds for operation of this membership have come from the City of Minneapolis' Gas Company Franchise fee. A unanimous vote of the members in attendence approved the assessment method for coming up with the \$40,000 funds for operation, and therefore if the Council concures, the City staff will prepare, as part of the 1984 budget, a line item covering the \$736.20 for Suburban Rate Authority assessment, under legislation.

Dear Mr. Brown:

At its July 20, 1983 meeting, the Suburban Rate Authority Board of Directors adopted a resolution authorizing \$40,000 in revenue during 1984 by an assessment of the membership. Under Article X of the Suburban Rate Authority Joint and Cooperative Agreement, the Board may establish a total annual contribution to be made by the membership during the following calendar year. The Agreement further provides that the contribution is to be spread across the membership in proportion to respective voting strength. There are a total of 163 votes among the 41 cities which are members. Each vote was assessed \$245.40. The City of Hastings has 3 votes and its assessment is \$736.20.

This letter is the notice of assessment required by the Agreement. The assessment is payable to the Suburban Rate Authority, c/o J.N. Dalen, Secretary-Treasurer, Edina City Hall, 4801 West 50th Street, Edina, Minnesota 55424. Assessments are payable 1/2 on or before February 1, 1984 and the remaining 1/2 on or before August 1, 1984. No statement will be sent.

Our quarterly minutes, sent to all members, have detailed SRA's activities. The most recent general benefit of membership in the SRA has been the negotiation with Minnegasco of a Uniform Gas Franchise Ordinance, which was(mailed to each member last May. The model ordinance was the result of lengthy negotiation with the gas company concerning the provisions of the ordinance. While the draft ordinance was negotiated with Minnegasco, it has been presented to at least one other gas utility, and it is likely that it will be used with gas suppliers other than Minnegasco. During discussion of the assessment at the SRA Board meeting, it was suggested that the draft ordinance itself was worth the cost of membership in the SRA and that most cities would have spent far more to negotiate individual ordinances, possibly with less favorable terms.

There has been only one previous assessment of SRA members, and that assessment was in a very small amount. Funding of SRA activities to date has come from a fund originally provided by the Minneapolis Gas Company as a franchise administration fee. The fee was paid to the SRA prior to the transfer of the responsibility for supervision of the company to the Minnesota Public Service Commission in 1975. That fund has been nearly depleted as a result of SRA's intervention in rate cases involving Northern States Power Company, Minnegasco, Northwestern Bell, and further by the Board's activities related to the Metropolitan Waste Control Commission.

Attendance at SRA Board meetings has been good; interest in its activities is keen. Our strength is dependent on our collective effort to continue the useful work of the SRA. Please find attached a letter from John McKane and Jim Schneider, of the Rebecca Task Force, and two payback schedules as prepared by City Staff.

As Mr. McKane has pointed out, the City owes a total of \$496,766.98 of which \$350,900 is due on August 27, 1983 and we have available \$444,828.48. It is Staff's recommendation that the City pay the amount due(\$350,900) as required by the agreement and pay the remaining amount over a 20 year period. The 10 year payback schedule shows the City realizing a savings of \$7,295.75. This results from an assumption made that the City would be able to earn 3% more than what its paying the Federal Government on the money that it owes.

The 20 year payback schedule shows a savings of \$22,284.80 if the City chooses to payback over a 20 year period. While it is true that carrying this payback schedule out to a 50 year period. The City could end up making money on the difference in interest, it is also possible that the 3% present margin would be less and it is also possible that the administration costs would consume the gain. Therefore, it is Staff's recommendation, that if in fact the interest amount of \$49,393.30 is due, that the 20 year payback schedule of the amount owed, be adopted.

It is also the Staff's recommendation to concur with Mr. McKane's opinion that the City Council should pursue the possibility of getting the interest charges waived from the Federal Government. Therefore, the following Resolution has been proposed for the Council's consideration.

RESOLUTION NO.

WHEREAS, the City of Hastings has entered into an agreement with the Army Corps of Engineers for the purpose of making improvements to Lake Rebecca, and;

WHEREAS, the City of Hastings has fulfilled all portions of the agreement as previously set forth, and;

WHEREAS, it was believed by the City Council of the City of Hastings and its Lake Rebecca Task Force, that there would be no interest charged to the City on the project until the completion of the project, and;

WHEREAS, at not time was the discussion of interest on the project during the construction mentioned by representatives of the Army Corps of Engineers, and;

WHEREAS, at no time in previous agreements with the United State Government has the City of Hastings paid interest during construction,

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Hastings, Minnesota that it hereby requests the Army Corps of Engineers to reconsider the charges of interest in the amount of \$49,393.30.

Dear Mayor Stoffel:

On behalf of the Lake Rebecca Task Force, we wish to announce completion of the resource restoration project ecnompassed in the Lake Rebecca Park and Natural Area.

While this project actually had its inception in 1957, the current Task Force began its work in the fall of 1973.

It has been a rather complex undertaking. We believe the Rebecca resource will be an exceptional asset to our community, whether viewed from the recreational, economic or esthetic standpoint.

We are most appreciative of continuing support of past and present City Councils.

And we would be remiss if we did not recognize the confidence and support of Hastings citizens: volunteer groups, organizations, and the great vote of confidence we received in the general referendum.

You recently received from the St. Paul District Office of the Corps of Engineers a final report of the total project cost, as well as allocations of the federal and Hastings cost-shares on the Rebecca project; specifically:

Total Project Cost..... \$1,278,073.10

Hastings cost-share 496,766.98

Federal cost-share 781,306.12

The federal government has given Hastings the option of paying its costshare in full 30 days from the date of the accounting notice you received, or on August 27, 1983, or:

Payment of \$350,900 down on August 27, 1983, with the balance payable over a 50-year period at 6.063% interest. (The City could also elect to pay off its obligation in less than 50 years.)

It is the unanimous opinion of the Task Force that the City of Hastings should excercise the down payment, 50-years or less option because of the unusually low interest rate.

In reference to the city cost-share of \$496,766.98, it should be pointed out that this sum includes interest charges of \$49,393.30 from the date of the project construction start in 1978.

This charge is particularly irksome to the Rebecca Task Force, for the following reasons:

- (1) At no time during the course of public hearings, meetings before the Hastings City Council, or at Task Force meetings all with Corps of Engineers representatives present was there any mention of interest charges from the date of construction.
- (2) Our communications indicate that this interest charge was also a "surprise" to the St. Paul District Corps project representatives, and not "understood" by this office.
- (3) We believe the City of Hastings contract with the Corps, while it makes mention of interest, was signed on the basis of information conveyed during the course of public meetings: in short, with the understanding that interest would be charged only from the date of project completion.
- (4) Finally, since it is our understanding that the Corps budget is by Congressional appropriation, the interest charge during the construction period is contradictory.

Summary: it is the Task Force recommendation that the Hastings City Council appeal the interest charge consideration, on the basis of the history of communications with the Corps, and as a matter of principle.

Regarding the Rebecca Project Funding, City of Hastings accounts disclose that, by the end of August, there will be approximately \$444,828.48 in this fund.

Rebecca shoreland acquisitions, and Rebecca parking lot and access road paving have already been paid.

Without the access roads-parking lot <u>add-on</u> costs of \$17,304 (a wise decision by the Council since the Corps paid a matching cost), the Rebecca Task Force would have been <u>over-subscribed</u> in meeting its Hastings cost-share goal of \$447,373.68.

The unanticipated interest charge by federal auditors in the amount of \$49,393.30 represents the single contentious point with the Task Force.

While it could be argued that the City of Hastings received an exceptional bargain for its total cost-share, we believe the interest matter should be vigorously contested.

So far as the Task Force is concerned, we have achieved our cost-share objective.

Again, we thank the City Council for its vision and cooperation over the past decade.

SUBJECT: COMPLETION - ICE ARENA RE-ROOFING

We have been reviewing the Ice Arena roof and the need to complete the re-roofing with insulation comparable to the completed top section. As you may be aware, last winter the partial re-roofing that was done created a vast differential in heat loss and the formation of a continuous ice bank on the roof at the point where the insulation and/or re-roofing ended. This thawing and/or freezing process created enormous weight on the roof that resulted in deflection of this roof of about two inches and causing concerns for the usage of the building and its occupants.

To properly address the problem mentioned above, I have been in contact with Mr. Thomas Nipper of Milo Engineers. In my discussions with Mr. Nipper, he indicates that the Tremco Company has given him an estimate for the completion of the Ice Arena roof. These costs for installation would be \$105 to \$110 thousand dollars. It was also suggested by Mr. Nipper that an open bidding for the project costs may be somewhat lower than this figure. Specifications for the re-roofing of the Ice Arena have been drawn before and would need little updating. I would feel that any cost necessary to let bids for the remainder of the project be minimal. Mr. Nipper has indicated that he would be willing to work with us on the completion of the project for estimated costs of \$2,500.

The City Administrator and I have been jointly working on this project and we offer the following method for financing. These monies will be available by the end of 1983.

Location: City Hall, Arena, and Police Department

This will confirm my loss control service visit to the above City locations on the indicated date. In addition to yourself I met with Mr. Merlin Wilbur, Building Inspector; Mr. Al Duratti, Arena Manager; Ms. Diane Latoff, Administrative Assistant; and Mr. Darryl Plath, Chief of Police. The purpose of this visit was to survey the arena, discuss response procedures on non-functioning traffic signals and to monitor the City's loss experience.

Activities and Discussions:

We first met at the City Arena with Mr. Wilbur and Mr. Duratti to discuss the roof leakage problem. My understanding is that ice and snow naturally built up along the line where the roof insulation terminates. The weight of the ice and snow apparently caused roof beams to deflect resulting in roof leaks and the potential for structural impairment. This is obviously a cause for concern and I have submitted a recommendation for further action which may be found at the close of this letter.

Afterwards, I met with Ms. Latoff and discussed loss experience and safety program.

Ms. Latoff and myself then met with Mr. Plath to discuss various policies and procedures in the Police department.

A review of the accidents for this period reveals relatively favorable accident experience with six low severity occurrences spread over five departments. No trends are discernable for this period.

Loss Control Program:

I reviewed the agenda of the safety orientation program attended by the seasonal parks employees. Topics included emergency procedures, fire safety, personal protective equipment, material handling and other. A program of this type is especially appropriate for the seasonal employees who are typically young and relatively inexperienced. These factors are directly related to high accident rates. Congratulations to the safety committee for arranging this presentation.

It was determined that all semaphores in Hastings, Minnesota, are the responsibility of the State of Minnesota and not Hastings. Police procedures for reporting non-functioning signals and safeguarding intersections were discussed and found to be satisfactory. Given the many hours police officers spend driving squad cars and the difficult emergency situations they face, it was gratifying to learn of the high priority given to behind-the wheel advanced driver training. All officers receive this training on an annual basis.

Recommendations:

Recommendation, 82-12-1, has been completed. The following new recommendation is being submitted at this time:

83-7-1

A structural engineer or architect should be consulted to devise a plan to fully insulate the roof or take other necessary action to prevent the build-up of ice and snow which is apparently causing the roof beams to deflect and allowing water to leak in the building.



The DNR is proposing to extend Mr. Roe's contract to include leaving one half of the interlocking sheeting which was used for the construction of the ramp. Mr. Roe is proposing that the City pay him \$14,175 to install the other half (750 square feet) of sheeting. Staff has reviewed this proposal and finds that the cost versus benefit is marginal based on the following:

Dear Mr. MacNamara:

I am responding to your request concerning the placement of additional sheet piling permanently around the ramp at the access under construction on the Mississippi River. Attached are plans indicating the extent that our engineers believe the sheet piling is necessary-49 lineal feet on the upstream corner of the ramp. The attached letter to the Army Corps of Engineers explains the reasons for the sheet piling. We have agreed to pay the contractor for installing these pilings.

In further discussions with our Engineering they do not believe additional sheet piling is necessary for protection of the ramp. However, this is a new access and the hydraulics of the river are not entirely predictable. Even sheet piling may not be adequate during a disastrous flood. However, it is the engineer's best judgement that the amount of sheet piling already provided for as cited above should suffice under normal conditions.

As you are aware, the Department of Natural Resources is currently in the process of constructing a new public access facility on the Mississippi River at Hastings. As per the Corps of Engineers permit number 83-91-23, granted on January 28, 1983 the DNR is permitted to "place rip-rap and construct a temporary cofferdam" as part of the construction of a double width concrete slab launching ramp.

August 10, 1983

Due to the sustained high water levels this past spring the condition of the river bottom in the area of the ramp has changed from what was found in the original survey completed in August of 1982. This survey data was used in the preparation of the final plans for the development and submitted with the original permit application. Currently the water depth is much greater at the ramp station points than what was found originally at approximately the same water levels. This creates the possibility of rapid erosion of the rip-rap and base material under and around the ramps. To prevent this erosion we are proposing the permanent installation of the sheet piling used for the cofferdam in the manner shown on the attached plan. It is felt this approach will adequately deter the erosion and ensure a safe and reliable launch ramp. We are therefore proposing that the Corps permit be amended to include this alteration.




