B. Community Development

1. **Resolution 12-10-13**: Variance #2013-34 – Signage - Regina Hospital (1175 Nininger Road).

Hinzman introduced the item explaining that Regina Hospital is seeking height variances for nine signs on the property. Two of the signs are along Nininger Road and the remaining seven are within the campus. The Planning commission has previous recommended approval of the variance. Cheryl O'Donnell from Vision Communications answered questions about illumination and location of the signs. Councilmember Alongi stressed that granting these variances is not intended to set a precedent but rather highlight the unique situation of the hospital and its need for adequate signage.

2. Hudson Redevelopment Update

Hinzman provided an update on the selection of a developer for the Hudson Site. At its' December 12th meeting the Hastings Economic

Development and Redevelopment authority (HEDRA) selected City Properties as the developer for the Hudson Site. There were three developers to choose from each with a viable proposal. The City Properties proposal will preserve the historical parts of the building, incorporate public space as well as utilize the riverfront.
