- Mesko Lee introduced the item requesting Special Event designation of the 2014 Get Hooked on Hastings: Cabela's Masters Walleye Circuit Fishing Tournament on May 1-3, 2014 to be held in Jaycee Park, which is being sponsored by the Hastings Area Chamber of Commerce & Tourism Bureau (HACCTB).
   Schultz, Nelson to approve as presented. 7-0
- 2. Approve Firefighter Relief Association Pension Increase moved from Consent Agenda. Mayor Hicks recommended that the council review future increases to pension amounts as the City has potential liability. Hicks, Alongi to approve as presented. 7-0

## VII. AWARDING OF CONTRACTS AND PUBLIC HEARING

 Public Hearing – Resolution 03-03-14- 2014 Neighborhood Infrastructure Improvements

Egger introduced the item requesting Council to conduct a Public Hearing regarding the scope and features of City Project 2014-2, the 2014 Neighborhood Infrastructure Improvements. Additionally, the Council requested to consider adopting a resolution ordering this project, approving the plans, and authorizing advertisement for bids.

Public Hearing was opened at 7:16 p.m. Gail Collins from 208 14<sup>th</sup> Street West spoke against the sidewalks and asked for a neighborhood vote. Public Hearing was closed at 7:20 p.m.

2. Public Hearing – Downtown Improvements

Egger introduced Brian Hilgardner and Jim Harbaugh from Bolton & Menk, the City's consultant for the project scoping study. They gave a presentation to show conceptual illustrations that have been developed based on their work with Scoping Study Advisory Committee, feedback from a public open house conducted in January, feedback gathered through the project website, and input from the City staff working group. Council is requested to hold a Public Hearing to solicit public comment and feedback on the concepts being developed for the Downtown Street, parking lot, and Levee Park Improvements project. There is no action on this project at this meeting; the Council will consider action when the final recommendations are brought forward by the Scoping Study Advisory Committee later in the Spring.

Public Hearing was opened at 7:56 p.m. Brian Ussatis of 750 3<sup>rd</sup> Street West asked about the funding sources for the project. Mayor Hicks explained the various potential funding sources. John Hauser of 1206 Lyn Way asked if boats would be able to park along the river or possibly having a marina. Mayor Hicks explained the Army Corps of Engineers restrictions with the angle of the river. Public Hearing was closed at 8:02 p.m.

Councilmembers had discussions about the Hastings letters, substation screening, bump outs in the downtown and parking. Councilmembers also expressed satisfaction with the work City staff and the consultants have done to date. Councilmember Alongi encouraged participants to define the public purpose when making recommendations.

## A. Public Works

a. Resolution 03-03-14 – Ordering 2014 Neighborhood Infrastructure Improvements, Approving Plans, and Authorizing Advertisement for Bids Schultz, Balsanek made motion to approve as presented. Discussion regarding the sidewalks ensued. Councilmembers who serve on the Operations Committee (Nelson, Balsanek, and Riveness) shared their reasons for voting for or against the sidewalks. Councilmember Schultz proposed an amendment to have sidewalks only between Vermillion and Eddy Street along 14<sup>th</sup> Street. The amendment was approved 7-0.

Roll call vote was taken; motion passed as amended 7-0.

## **B.** Community Development

i. Resolution 03-04-14: Support of Job Creation Fund Application – Hexfuel

Hinzman introduced the item requesting approval of the resolution supporting a Minnesota Department of Employment and Economic Development (DEED) application for assistance under Job Creation Fund for Hexfuel. The Hastings Economic Development and Redevelopment Authority (HEDRA) held a public hearing and reviewed the application at the February 13, 2014 meeting. Comments from the public and HEDRA Commissioners were favorable. HEDRA unanimously supported the application. Schultz; Hollenbeck to approve as presented. 7-0

- ii. Authorize Signature: Right of First Refusal Agreement Hexfuel Hinzman introduced the item requesting authorization to sign the Right of First Refusal Agreement between the City and Hexfuel, LLC. for property within the Hastings Business and Industrial park. Under the agreement Hexfuel would be given the opportunity to match any offer for the subject property for a period of up to five years. The Hastings Economic Development and Redevelopment authority (HEDRA) reviewed the application and unanimously supported signature of the agreement. Stuart Helgason from Hexfuel spoke and said the company is looking forward to bringing their business to the City of Hastings. Alongi, Riveness to approve as presented. 7-0
- iii. Resolution 03-05-14: Special Use Permit Shoreland Development South Pointe

  Hinzman introduced the item requesting council take action on the proposed plat, which requires review of preliminary and final plat, site plan, and Conditional Use Permit. The Planning Commission has previously recommended unanimous approval of the proposal.
