VII. AWARDING OF CONTRACTS AND PUBLIC HEARING

These are formal proceedings that give the public the opportunity to express their concern, ask questions, provide additional information, or support on a particular matter. Once the public hearing is closed, no further testimony is typically allowed and the Council will deliberate amongst itself and with staff and/or applicant on potential action by the Council.

1. Public Hearing – Second Reading/Ordinance Amendment Chapter 155 – Signs Hinzman introduced the item which seeks to provide clarification on allowable signs and definitions. The ordinance revision also creates an on-line temporary sign notification form would remove ambiguity by establishing a beginning and endpoint for the placement of temporary signage. There would be no fee for completion of the notification form. The Planning Commission began talking about this topic in late 2013 and has had several meetings since then, ultimately approving the recommended changes on a split vote. Hastings temporary signage regulations are among the least restrictive of comparable surrounding cities.

Public Hearing was opened at 7:42 p.m.

Richard Jacobson of Jake's Discount Liquor spoke opposing the ordinance and commented on the time spent on this issue.

Adam Estenson, Vice Chair of the Planning Commission, spoke against the online notification form.

Public Hearing was closed at 7:47 p.m.

Council had considerable discussion on the issue and received clarification on the staff time that would be involved in administering the form and the purpose of the form. Mayor Hicks explained the history of the current sign ordinance and how it was a collaborative effort between the City and the Chamber of Commerce.

2. Public Hearing – Second Reading/Ordinance Amendment Chapter 34 – Park and Recreation Fees

Jenkins introduced the item stating that the Parks and Recreation Commission approved recommendations to the fee schedule. The revisions attempt to clean up a number of fees to better align them with actual costs.

Public Hearing was opened at 8:05 p.m.

Cindy Lyon, President of Hastings Youth Athletic Association, spoke with concerns about the proposed tournament fee structure.

Public Hearing was closed at 8:10 p.m.

Council asked for clarification on the tournament fees and how they have been administered in the past. Councilmembers also had concerns with the proposed increase to the memorial bench and tree fess. Councilmember Alongi encouraged staff to consider incentives for volunteer efforts
