2. Resolution 12-06-14 – Site Plan #2014-41 – Regina Hospital Emergency Room Hinzman introduced the item explaining that Allina is proposing to expand the existing emergency department on the back side of the existing Regina Medical Center. The addition will be approximately 13,400 square feet in size, and will include an ambulance garage. The Planning Commission has previously recommended approval subject to the conditions of the Resolution.

- 3. Resolution 12-04-14 Consider Improvements to TH 316 & Tuttle Drive Hinzman introduced the item which requests consideration by the Minnesota Department of Transportation (MnDOT) for certain transportation changes on TH 316 (Redwing Boulevard) in the vicinity of Tuttle Drive, which include:
 - Access to TH 316 should be improved to better facilitate access from Tuttle Drive; construction of a roundabout or traffic signal should be considered.
 - The existing 35 mph zone along TH 316 located north of Tuttle Drive should be extended south to the City limits near Michael Avenue to be consistent with neighboring residential development.

The TH 316 traffic conditions were discussed by the City Council as part of the November 17th approval of South Pines 8.
