1. Public Hearing – Second Reading/Adopt Ordinance No. 2015-01 – Exterior Lighting

Fortney introduced the item noting a summary of exterior lighting requirements which included surrounding area cities. Generally these cities included similar footcandle illumination limits similar to Hastings and many direct the manner in which light should be directed as downward, on during business hours only, and away from residential areas. The Planning Commission unanimously recommends approval of this ordinance amendment.

2. Public Hearing – Second Reading/Adopt Ordinance No. 2015-02 – Dairies and Creameries in the C-3 District

Fortney introduced the item explaining that dairies and creameries were once allowed within the C-3 District of the Zoning Code. In 1975 Hastings Coop was granted a special use permit as a creamery in the C-3 District. It appears the language was eliminated during a zoning code rewrite in 1996. The removal of the dairy/creamery provision within the zoning code has made the Coop a non-conforming use. The Planning Commission unanimously recommends approval of this ordinance amendment.
