 - 1. Appeal of Heritage Preservation Commission Decision: Andy McCoy (209 7th Street W)

Fortney introduced the item which requests Council review the decisions made by the Heritage Preservation Commission for the property at 209 7th Street West owned by Andy McCoy. Council has authority to affirm or reverse each of the following, or direct the matter back to the HPC for further consideration:

- a. Request to reaffirm a 2008 approval to relocate the detached garage
- **b. Front addition (turret)**
- c. Rear addition
- d. Garage and partial house demolition

Homeowner Andy McCoy talked about his reasons for requesting the appeal. Considerable council discussion about timelines, history of the requests, role of HPC, changes for accessibility reasons, reasons for sunset clauses and rationale for decisions to approve or deny these type of requests. Acting Mayor Alongi encouraged Mr. McCoy to work with the HPC and City staff to come to a resolution. Motion by Councilmember Braucks and seconded by Councilmember Balsanek to table and send to Historic Preservation Committee of the Council for further discussion. 5-0

 Resolution 05-08-15—Special Use Permit 2015-18 – Operation of a Commercial Use in the I-1 District (Fitness Training Center) - Aaron Sidner – 2939 Enterprise Ave.

Fortney introduced the item which requests the granting of a Special Use Permit for Redline Project to operate a performance training center at 2939 Enterprise Avenue. The Planning Commission has previously unanimously approved this request submitted by Aaron Sidner of Redline Project.

Acting Mayor Alongi noted that approval of a Special Use Permit requires six votes and asked that this item be tabled until the June 1 council meeting.
