VII. AWARDING OF CONTRACTS AND PUBLIC HEARING

These are formal proceedings that give the public the opportunity to express their concern, ask questions, provide additional information, or support on a particular matter. Once the public hearing is closed, no further testimony is typically allowed and the Council will deliberate amongst itself and with staff and/or applicant on potential action by the Council.

1. Public Hearing – Rezone Property from R-1 to PI – Shepherd of the Valley Church (1450 West 4th Street)

Hinzman introduced the item which requests considering a 2^{nd} Reading and order Public Hearing to amend City Code Chapter 155.01 – Zoning Map. Shepherd of the Valley Church would like to develop a fitness facility as part of their church in the walkout basement, which is about 4,800 SF and has a separate door to the lower parking lot. The current zoning or R-1 Low Density Residence would only allow for uses incidental to the church. Since the church would sell fitness facility memberships to the public, it would not be considered an incidental use. The PI – Public Institution district allows for churches and fitness facilities. The Planning Commission has previously approved this request by a 4-1 vote.

Public Hearing opened at 7:15 pm

Several neighbors with adjoining properties spoke with concerns about a business within a residential area, lighting, safety, traffic noise and effect on property values.

Pastor Chad Kirchoff added that the fitness facility would be open 24/7 and memberships would be sold to the general public and not only members of the church.

Public Hearing closed at 7:32 pm

Council discussion on licensing oversight, regulation of hours and what would be allowable in a Public Institution district. Hinzman clarified that fitness facilities were added to the Public Institution district to accommodate the YMCA a number of years back. Mayor Hicks questioned if the rezoning could be denied given that a fitness center is a permitted use.

A. Public Works

1. Resolution 11-05-15 - Conditional Approval – Funding Agreement with State of Minnesota for Veterans Home Sewer Project Egger introduced the item which requests City Council to conditionally approve a Grant Agreement with the State of Minnesota for the Veteran's Home Sewer Reconstruction and Replacement Project. The Minnesota Veteran's Home sewer mains are in poor condition, resulting in both blockages and inflow of storm water into the sanitary sewer system. City staff has been working with the Minnesota Department of Veteran's affairs and the State Department of Administration to formulate an agreement where the City would design and manage state funded reconstruction/repair of the Veteran's Home sewer mains to eliminate these problems. 2. Easement Agreement - Veterans Home Sewer Project

Egger introduced the item which requests Council to adopt a resolution conditionally approving the City's entry into an easement agreement with the State of Minnesota for the City to retain perpetual access rights on the MN Veteran's Home property to service and maintain the main sanitary sewer line that would be addressed by the Hastings Minnesota Veterans Home Sanitary Sewer Reconstruction and Rehabilitation Project. The City would be allowed to place and maintain a recreational and maintenance access trail on the same area of the property. Staff recommends approval of the adoption of this resolution, on the condition that the City first enter into the Funding Grant Agreement with the State of Minnesota.

 - 1. 2nd Reading/Adopt Ordinance 2015-13 Rezoning from R-1 to PI Shepherd of the Valley Lutheran Church (1450 West 4th Street) Motion to deny rezoning by Councilmember Vaughan and seconded by Balsanek.

 - 2. Presentation Great Rivers Landing land Use Approvals, (former Hudson Manufacturing Building) 200 West 2nd Street
 Hinzman introduced the item which requests Council to review actions for the development of Great Rivers Landing, a rehabilitation of the former Hudson Manufacturing Facility located at 200 West 2nd Street. Confluence Development proposes to renovate the existing 100,000 square foot building into 60 apartment units and 20,000 square feet of retail and events space. The site is currently owned by the Hastings Economic Development and Redevelopment Authority (HEDRA). The HEDRA and Planning Commissions have previously unanimously voted to recommended development plan modifications, establishment of the TIF District, and sale of the property to Confluence Development.

3. Resolution 11-07-15 – Reconsideration of City Council Action/Approval of Vacation of Easement – Riverwood 7th Addition (Woodland Court)

Motion to reconsider item by Councilmember Balsanek seconded by Councilmember Alongi.

Greg J. Homes has requested reconsideration of the denial of a vacation of easement request for Riverwood 7th Addition. During the October 19th public hearing for the vacation, staff incorrectly noted that the homes appeared to be single family (different than the existing twin homes on Woodland Court). The developer clarified that his original intent was to construct two detached townhomes and one twin home on the site; and that he had shared these plans with the neighbors who were in agreement with the plans.

Jerry Rehnke of 1122 Woodland Drive spoke in favor of the changes. The developer commented that construction would begin immediately.
