#### VII. AWARDING OF CONTRACTS AND PUBLIC HEARING

These are formal proceedings that give the public the opportunity to express their concern, ask questions, provide additional information, or support on a particular matter. Once the public hearing is closed, no further testimony is typically allowed and the Council will deliberate amongst itself and with staff and/or applicant on potential action by the Council.

 Award Contract – Resolution 04-05-16 – Riverfront Renaissance Phase 3 Improvements

Egger introduced the item requesting Council approve a resolution awarding a contract for Phase 3 of the Riverfront Renaissance Improvements project. The City received three bids for this project on March 24<sup>th</sup>. Pember Companies, Inc. was the lowest bidder with \$2,921,380.75. After a reference check by City project consultant Bolton & Menk, staff recommends approval of Pember Companies, Inc. being awarded the contract. Construction is intended to being in April with substantial completion by early October.

Council discussion on removal of alleys from project scope, state legislature funding, electrical work grant opportunities, and option of re-bidding project.

Resolution 04-06-16 – Approve Plans, Order Improvements, & Authorize Advertisement for Bids – 2016 Neighborhood Infrastructure Improvements Stempski introduced this item which requests Council to adopt a resolution ordering the 2016 Neighborhood Infrastructure Improvements, approving the plans, and authorize advertisement for bids. The Public Hearing for this project was conducted on March 21<sup>st</sup>. Staff was directed by Council to report back on issues in more detail at the April 4<sup>th</sup> City Council Meeting. Stempski explained the origin of the alley proposal, reduction of maintenance efforts, reduction of erosion and sediment in storm water, limiting of encroachments, opportunity to improve drainage, minimization

of icing and increased safety, and cleaned up appearance and aesthetics. Parking and traffic impacts on surrounding streets was discussed.

Mayor Hicks allowed public comment in addition to the Public Hearing which was held on March 21<sup>st</sup>. Several neighbors spoke with concerns about the alleys, Bailly Street traffic, additional stop signs, drainage, and safety.

Council discussion on the maintenance of alleys, necessity of paving alleys, Tyler and Bailly Street traffic, addition of a stop sign, financial impact of removing alleys from project, and sediment run off.

Councilmember Alongi offered an amendment to remove the alley work from the project and add a stop sign on Tyler and  $7^{th}$  Streets. No second was received.

Addition of stop sign at Tyler and  $7^{th}$  will be brought back to the City Council in the future.
