Hinzman introduced the item requesting Council to hold a public hearing and consider 2<sup>nd</sup> reading and adoption of an ordinance amendment opting out of State Statute requirements pertaining to

Temporary Family Health Dwellings. In May 2016 Governor Dayton signed into law a bill that passed this legislative session that requires cities to allow temporary family health care dwellings unless the City passes an ordinance before September 1, 2016 opting out of this statute. A temporary health care dwelling would be occupied by a mentally or physically impaired person on a residential lot that is owned/or occupied by a relative or caregiver of the mentally or physically impaired person. The Planning Commission and Planning Committee of City Council have previously unanimously recommended opting out of the provision.
