Consider Action on Violation of Pawn Broker License - Old Mill Pawn

2324 Vermillion Street, Hastings

COUNCIL ACTION REQUESTED.

The City Council is requested to consider action and conduct a hearing on alleged violations of the pawn broker license of Old Mill Pawn for failing to pay monthly billable transaction fees in a timely manner.

BACKGROUND INFORMATION.

Robert Bohn of Old Mill Pawn shop located at 2324 Vermillion Street in the City of Hastings was issued and has held for many years a pawn brokers license under City code §110.11. City code requires in §110.11(E)(4) that billable transaction fees shall be billed monthly and are due and payable within 30 days. Failure to do so is a violation of City code. City code §110.11(S) provides in part, that a pawn broker license may be suspended or revoked for any failure by the licensee to comply with provisions of the City code. In addition, City code §110.11(E)(4) provides that the City Council, following notice and an opportunity for hearing, may impose a financial penalty of \$250.00 for fees past due up to thirty (30) days and may impose a financial penalty of an additional \$500.00 for fees past due more than thirty (30) days.

Old Mill Pawn failed to pay monthly transaction fees on time in 2012 and that violation had been brought before the City Council for action. Because Old Mill Pawn had paid all outstanding fees before the City Council took action, the City Council took no further action to suspend or revoke the pawn license but Old Mill Pawn was notified that any subsequent failure to pay fees in a timely manner would result in the matter being brought before the City Council for consideration of formal action, including suspension or revocation of the pawn license.

Old Mill Pawn was once again delinquent on payment of fees earlier this year and by letter dated June 29, 2016, the City notified Mr. Bohn of the delinquencies, that the ordinances required timely payment and that failure to make timely payment could result in a license suspension or revocation plus the imposition of the monetary penalties set forth above. Although some subsequent payments may have been made, all delinquent fees have not been paid in full as of

the date of this memo. By letter dated November 10, 2016, Mr. Bohn was notified that the outstanding monthly transaction fees for invoices issued by the City dated September 7, 2016 and October 5, 2016 remain past due and as a result, the matter is being referred to the City Council for action at the November 21, 2016 meeting which may include imposition of monetary penalties and suspension or revocation of the pawn broker license. A copy of that letter is attached hereto.

The City Council is therefore asked to conduct a hearing based on the foregoing violations and if, following the hearing, the City Council determines Old Mill Pawn has failed to pay monthly transaction fees in a timely manner, to impose sanctions that may include imposition of the monetary penalties allowed by the ordinance or suspension or revocation of the pawn broker license. At the hearing, the licensee must be given the right to address the City Council, to be represented by an attorney of his choosing, to present evidence by witness testimony or document exhibits, to cross examine any witnesses, and to have the proceedings transcribed at his cost. The hearing will be open to the public and the City will record any proceedings. I expect the licensee will effectively acknowledge the late payments but may want to address the City Council. We will need to conduct the hearing accordingly. Because of the history of failure to comply with the payment requirements, I am expecting the City Council may wish to suspend the pawn broker license for a number of days but certainly the City Council could take different action depending on what is learned at or before the hearing. To that end, however, I am providing a simple resolution that would document the violations and would allow the Council to impose a suspension of the pawn broker license for a specified number of days.

This process is somewhat similar to what is used for unlawful sales to minors under the liquor license ordinance but there are no presumptive penalties included in the pawn broker license ordinance. The City also does not have any other pawn broker licenses issued so we do not have a precedent established on what is an appropriate sanction in this situation. Therefore, the City Council will need to determine what it believes to be appropriate for a sanction based on the circumstances and history.

FINANCIAL IMPACT.

There should be no financial impact to the City other than to require monthly billable transaction fees be paid on time plus receipt of any monetary penalties that may be imposed.

Council Action Requested:

The City Council is requested to consider action and if deemed appropriate, conduct a hearing on alleged violations of the pawn broker license of Old Mill Pawn for failing to pay monthly billable transaction fees in a timely manner.


Background Information:

Robert Bohn of Old Mill Pawn shop located at 2324 Vermillion Street in the City of Hastings was issued and has held for many years a pawn brokers license under City code §110.11. City code requires in §110.11(E)(4) that billable transaction fees shall be billed monthly and are due and payable within 30 days. Failure to do so is a violation of City code. City code §110.11(S) provides in part, that a pawn broker license may be suspended or revoked for any failure by the licensee to comply with provisions of the City code.

Monthly transaction fees for the months of December 2011, and January, February, and March 2012 have been billed to Old Mill Pawn by invoice. For each bill, it was noted that payment is due within 30 days; late fees have been applied to each month's fees in accordance to City policy.

It is possible the monthly transaction fees will be paid prior to the City Council meeting. A copy of the May 15, 2012 letter sent to Mr. Robert Bohn on behalf of Old Mill Pawn shop is attached to the materials.

Generally, if the City Council is inclined to take any action against this pawn broker license, the licensee must be first provided an opportunity to request a hearing before the City Council. This is somewhat similar to the hearings provided when there is a violation of a liquor license, but with some differences. At the hearing, the licensee must be given the right to address the City Council, to be represented by an attorney of their choosing, to present evidence by witness testimony or document exhibits, to cross-examine any witnesses, and to have the proceedings transcribed at their cost. The hearing will be open to the public and the City will record any proceedings.

Because the City Council has not been asked to take action regarding a business license in a similar situation in the past, it is difficult for staff to make a recommendation as to the appropriate outcome or sanction. Unlike sanctions related to a liquor license violation, any sanction regarding the license in this matter would need to be limited to a suspension or revocation of the license, but City ordinances do not expressly authorize imposition of a monetary penalty.

From City staff perspective, perhaps the most important goal is to ensure the licensee makes all future payments in a timely manner as required by the ordinance without unnecessary staff time needed to collect those fees. To accomplish that goal, City Council could consider:

- A brief suspension of the pawn broker license;
- A suspension of the license but with the effectiveness stayed upon certain conditions including timely payment for a specified time frame;
- Other action as deemed appropriate; and/or
- Possibly just a firm conversation with the licensee making clear that any future delinquent payments will likely result in a significant license suspension.

I am enclosing with this memorandum a partially completed resolution that could be used by the Council to establish the necessary findings and to impose some sanction if a violation is found to have occurred.

Financial Impact:

There should be no financial impact to the City other than to require monthly billable transaction fees be paid on time.

Dear Mr. Bohn:

To remain in compliance with a pawn shop license issued by the City of Hastings, payment of monthly transaction fees within 30 days of the bill is required. Unfortunately, you continue to fail to pay the monthly fees in a timely manner. At this point, there is currently \$264.87 in outstanding monthly transaction fees. This reflects monthly transaction fees from February 2012. Attempts to contact you directly, including conversations from Investigator Katie Booth, phone calls to both Old Mill Pawn as well as your home, to remedy these charges have been unsuccessful.

Accordingly, this item will be placed on the agenda for the May 21, 2012 City Council meeting for action, which may include suspension or revocation of your pawn broker license for failure to pay billable transaction fees within 30 days as required by City Code 110.11: Pawn Brokers. While this item will be placed on the agenda irrespective of any payments received, I would strongly encourage you to make any outstanding payments immediately. At the hearing, you will have the right to address the City Council, to be represented by an attorney if you wish, to present evidence by witness testimony or document exhibits, to cross-examine any witnesses, and to have the proceedings transcribed at your costs. The hearing will be open to the public.





In 2012 the City Council adopted a change to Ordinance 110.11 Pawn Brokers in response to fees not being paid timely. It reads, in part, as follows:

- (4) Billable transaction fees shall be billed monthly and are due and payable within 30 days. Failure to pay billable transaction fees when due is a violation of this section and will result in the following monetary penalties in addition to any license suspension or revocation imposed by the City Council following notice and an opportunity for hearing:
 - (a) Fees past due up to thirty (30) days shall result in a \$250 penalty.
 - (b) Fees past due more than thirty (30) days shall result in an additional \$500 penalty.

Please be advised that going forward untimely payment will result in the above penalties being applied to your account and additional City Council action regarding your Pawn Broker license may follow. I encourage you to make payments in a timely manner.

RESOLUTION 11-21-2016-____

A RESOLUTION MAKING FINDINGS, CONCLUSION AND DECISION IMPOSING LICENSE SANCTIONS UPON ROBERT BOHN AND OLD MILL PAWN SHOP

BE IT RESOLVED, by the City Council of the City of Hastings, Minnesota, as follows:

WHEREAS, a hearing was held by the City Council pursuant to Hastings City Code Section 110.11 on November 21, 2016 at which testimony and written evidence were received; and

WHEREAS, Robert Bohn was afforded the opportunity to participate in the hearing on behalf of himself and Old Mill Pawn Shop as pawn broker licensee.

NOW, THEREFORE, based upon the evidence and testimony the City Council of the City of Hastings, makes the following:

FINDINGS

- 1. Robert Bohn, d/b/a Old Mill Pawn Shop (herein "Old Mill Pawn"), 2324 Vermillion Street, Hastings, Minnesota, holds a pawn broker license issued by the City of Hastings.
- 2. City Code Section 110.11(E)(4) provides that pawn broker billable transaction fees shall be billed monthly and are due and payable within 30-days and failure to do so is a violation of the City Code.
- 3. On September 7, 2016, the City of Hastings issued an invoice to Old Mill Pawn for monthly transaction fees due for the month of July 2016 in the amount of \$75.60. Those fees were due to be paid by October 7, 2016.
- 4. On October 5, 2016, the City of Hastings issued an invoice to Old Mill Pawn for monthly transaction fees due for the month of August 2016 in the amount of \$79.65. Those fees were due to be paid by November 4, 2016.
- 5. As of November 14, 2016, Old Mill Pawn had not paid the monthly transaction fees as set forth above for July and August of 2016.
- 6. Old Mill Pawn did not pay the foregoing monthly transaction fees within 30-days after Old Mill Pawn was invoiced for those fees.

CONCLUSIONS

Old Mill Pawn failed to pay the entire monthly transaction fees for July and August of 2016 within 30-days from the dates of receipts of the invoices for those fees in violation of City Code Section 110.11(E)(4).

ORDER

	HEREBY ORDERED, pursuant to City Code Section 110.11(S) that Robert Bohn Pawn Shop is subject to the following sanctions:
(1)	A suspension of the pawn broker license of Old Mill Pawn for days beginning at 12:01 a.m. on
	e to comply with this order will subject the licensee to further sanctions including cation of the pawn broker license.
