Item: First Reading/Ordinance Amendment - Adjustment of 2016 Fees

Council Action Requested:

Council is requested to conduct a first reading and order a public hearing for December 19, 2016 to consider an ordinance amendment adjusting various City fees.

Background Information:

As part of the annual budget process fees are reviewed for relevancy combined with a review of overall cost to provide said service. For 2016 the following fee adjustments are being recommended for consideration:

City Clerk License Fees:

• Addition of Lifetime Dog License Option - \$30 Neutered/spayed, \$45 Not neutered/spayed. Two-year license fee option will remain (\$12/neutered/spayed; \$20/non).

Finance Fees

- Elimination of Special Assessment Letter Fee (\$25.00)
- Addition of Conduit Debt Fee --\$5,000 deposit and administrative fee at closing equal to one-half percent of the original principal amount of the debt.

Building & Inspection Fees:

Building Permits—The City currently is using a valuation table for all general construction when no specific fee is provided. Staff is recommending that an updated valuation table be adopted. Permit fees are reviewed and adopted by ordinance by the City Council. Permit fee valuation shall be determined by the "Cost per square foot valuation data", which is published periodically by the Department of Administration State of Minnesota or actual total cost documentation provided by the permit applicant showing all costs for material and labor and approved by the Building Official.

AN ORDINANCE OF THE CITY OF HASTINGS, MINNESOTA AMENDING CHAPTER 34 OF THE HASTINGS CITY CODE PERTAINING TO FEES FOR MUNICIPAL SERVICES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HASTINGS AS FOLLOWS:

Chapter 34 of the Hastings City Code is hereby amended as follows:
