Cub Discount Liquors

Fluegel introduced the item and Mecca Page, owner of BreakAway Arts Café addressed the Council and asked for leniency on the presumptive penalties. BreakAway Arts waived a factual hearing. Council discussion on granting leniency to new businesses and setting precedent by not following penalties in ordinance.

Councilmember Lund made a motion to impose a \$500 civil penalty and stay the 3 day license suspension if BreakAway Arts Café were to enroll, in writing, in the Best Practices Program by March 1, 2017. Seconded by Councilmember Braucks.
