A. Public Works

- 1. Resolution 07-15-17 Monument Sign Design Approval Egger introduced the item requesting Council to consider approval of a master design for new monument signs at entry points along major highways into the City. After a one-week online poll in which more than 2,000 people participated, there was a clear preference for the "custom" sign layout over the "traditional design". The first sign would be installed at 3rd Street and Highway 61. Council discussion on favorable pricing to include lighting, landscaping and installation, option provides a fresh look, size of center logo graphic, and dimensional lettering.

Resolution 07-16-17 Limited Use Permit Application for Monument Sign Egger introduced the item requesting Council to adopt a resolution to move forward with making an application to the Minnesota Department of Transportation for a limited use permit to place a monument sign in the right of way.

Hinzman introduced the item which requests authorizing the submittal of revisions to the Livable Communities Demonstration Account Grant Agreements with Metropolitan Council for the Hudson property redevelopment. Revisions were made to the landscaping and parking designs. The grant funds total approximately \$2.5 million dollars. Council discussion on a plan for cost overruns, maintenance responsibility of parking structure, signage and height limitations in historical district, expansion capabilities of parking structure, total cost, number of parking stalls, esthetics, and if the parking lot project should be let for public bid.

2. **Resolution 07-17-17**: Variance #2017-24- Sideyard Setback – Beyer (1380 Hillside St)
