IV. New Business 6:15 p.m.

a. Park Dedication: Glendale 5th Addition

Director Jenkins introduced Community Development Director, John Hinzman. Community Development Director, John Hinzman, provided an overview of Glendale Heights 5th Addition.

The Parks and Recreation Commission was asked to review the method of park dedication as part of Glendale Heights 5th addition. Options include; Cash in lieu of land, physical land dedication, or a combination of the both would meet the requirements of the ordinance. Commissioners discussed options and Director Hinzman answered Commissioners questions. Commissioner Pemble motioned to provide a recommendation to City Council for Cash in Lieu of land and for City Council to look for potential future park sites in the neighborhood. Commissioner Spader seconded the motion. Motioned approved; 5 ayes, 0 nays.
