a. Discuss potential sites for a new neighborhood park near Veterans Athletic Complex

Director Jenkins introduced potential sites for a new neighborhood park using the Dakota County GIS website. Jenkins identified locations on City acreage. Commissioners and Director Jenkins reviewed the acreage including: the neighborhoods it will serve, accessibility, space, multi-function, nature based-play, inclusive structures and

additional aspects. Director Jenkins requested Commissioners support and direction on whether to continue with further investigation.

Commissioner Pemble recommended the Parks and Recreation Commission to continue further investigation. Parks and Recreation Commission agreed to continue researching and discussing a potential site for a new neighborhood park near Veterans Athletic Complex.

Parks and Recreation Commissioner, Pemble, motioned to make a recommendation to City Council for new Park considerations. Commissioner Piskor seconded the motion. Motion approved: 5 ayes, 0 nays Commissioners and Director Jenkins will a plan time to schedule a visit to the sites or visit individually.

a. Review circle bench options for memorial program

Commissioners reviewed the circle bench options including style, pricing and structure. Director Jenkins welcomed Commissioners to share their recommendation on whether or not to include the option in the Memorial Bench Program Guide for 2018.

Jenkins reminded Commission the Updated fee schedule is due by December 1, 2017 for the City Council meeting, Monday, December 4, 2017. Director Jenkins will put together a final price on the cost of the circle bench, including installation and on-going maintenance.

Commissioners will discuss the idea further at upcoming Parks and Recreation Commission meetings.
