Public Hearing – Authorize Disposition of City Property – Hudson Manufacturing (200 West 2nd Street)
Hinzman introduced the item requesting Council hold a Public Hearing and Adopt a resolution
authorizing disposition of a portion of City property located between the former Hudson Manufacturing
Property and the Mississippi River. HEDRA bought the Hudson property, Hudson conveyed to HEDRA
any interest they owned in land lying between the platted property and river. However, the City

probably holds rights in that land as a result of the dedication of the levee language in the 1855 Original Plat of Hastings and possibly other public dedications. In order to avoid any overlapping ownership issues in conveyance of land to Confluence, we seek to convey interest in the land to Confluence via the Great River Landing Final Plat. Transfer of the property will allow for redevelopment of the former Hudson Building into a taxpaying draw for downtown and the greater area.
