Council discussion as to if building can be torn down in future, timing of ownership, construction, and remaining City obligations to spend funds, impacts of Option B decision on Vapor Mitigation System, who contracts work, define calendar for completion and minimum improvements, and risk to City if changes need to occur to Vapor Mitigation System, impacts on HEDRA fund balance.

4. Order Public Hearing: Vacation of Right-of-Way- 1st Street (Hudson Manufacturing)

Hinzman explained the item and Attorney Fluegel provided further clarification on definition of vacation and the City vacating the public right-of-way for 1st Street from the 1855 plat does not impact the public use agreement which allows for perpetual public use of space.
