 Public Hearing - Vacation of Alley - Block 5 and 6 - Hudson Manufacturing Hinzman explained during review of the Great Rivers Landing plat for recording, it was determined this small area of the alley was never vacated. The remaining portions of the alley were vacated as part of three separate actions dating back as early as 1927.
 Public Hearing opened at 7:09
 Bruce Reuter of 321 1st Street West shared concerns about ownership of the land to be vacated. Attorney Fluegel explained the City has done extensive research on this matter.

2. Resolution 03-07-18 – Award Contract for Riverfront Renaissance Phase 3.1 Egger asked Council to adopt a resolution awarding a contract for Phase 3.1 of the Riverfront Renaissance, combining the Base Bid and Alternative No. 2, which will allow for burial of overhead utilities beneath the alley surface. Upon approval the contract will be awarded to Global Specialties.

1. 2018 Rivertown Days Agreement

Mesko Lee introduced the item requesting Council designate 2018 Rivertown Days as a special event. This is the 40th anniversary of the event and the Rivertown Days Committee has requested a significant change in the events location from prior years to provide increased walkability to main Rivertown Days events. Staff has worked with organizers to address accessibility and public safety elements of the new layout. The amount of in-kind City contribution will remain essentially the same as in previous years.

Kristy Barse, President of the Chamber of Commerce, provided a comprehensive explanation of the 2018 Rivertown Days events and changes.

Pete Likes, of 4th Street East shared concerns about access to East Side of Hastings by residents, marina patrons, and emergency vehicles on Tyler Street and traffic/parking during fireworks.

Another resident from 3rd Street East discussed traffic, East Side

access from Tyler Street and business parking needs.
Council discussion on options for parking in downtown, carnival

location, Tyler Street access, shuttle options, utility connections, generator use, fireworks location, labyrinth use, East Side resident concerns, parade route, and excitement for event to utilize riverfront. Vaughan, Balsanek to approve as presented.
