Chief Schafer discussed the special event application and conditions for 2019 Historic Hastings Downtown Cruise-In. The event would start Saturday, June 15, 2019 and continue every other Saturday through September 7, 2019 from 4:00 p.m. to 9:00 p.m.

Resolution No. 03-06-19: Support of Comprehensive Transportation Funding
