Item: 2020 Massage Therapy License and 2020-2022 Massage Therapy Establishment License Renewals – Fischer

Council Action Requested:

Adopt the attached resolution approving Ann Fischer’s 2020 Massage Therapist License and 2020-2022 Massage Therapy Establishment License Renewals.

Background Information:

City Ordinance 116 requires that:

- Massage therapists practicing within the City of Hastings be licensed annually. The licensing period for a massage therapist is January 1 through December 31.
- Massage therapy establishments within the City of Hastings be licensed every three years. The licensing period for a massage therapy establishment is January 1 of the first year through December 31 of the third year.

The City has received and reviewed Ms. Fischer’s application for a 2020 Massage Therapist license renewal and a 2020-2022 Massage Therapy Establishment license renewal. Ms. Fischer has paid the associated license fees, submitted the required documents and successfully passed the background check conducted by Hastings Police Department.

Approval and issuance of the Massage Therapy Establishment License is contingent upon the establishment’s passing the Fire Marshal’s inspection, per City Code.
