Item: Resolution: Authorize Submittal of 2020 CDBG Budget

Council Action Requested:

Adopt the attached resolution authorizing submittal of the 2020 Community Development Block Grant (CDBG) budget to Dakota County. The estimated funding of \$68,284 would be allocated towards assessment abatement. Action requires a simple majority of Council.

Background Information:

CDBG funding is intended to fund activities for low and low\moderate income individuals including affordable housing, anti-poverty, and infrastructure development. Dakota County receives a direct allocation of CDBG funding from the US Department of Housing and Urban Development (HUD) and suballocates funding to individual cities within the County.

Assessment Abatement – Similar to past years, CDBG funding would be allocated toward providing assessment abatement for local public infrastructure projects; allowing qualifying homeowners to reduce or eliminate their assessment.

Financial Impact:

CDBG funds will assist low to low\moderate income households in abating assessments and housing repairs.

A RESOLUTION APPROVING THE APPLICATION FOR FISCAL YEAR 2020 DAKOTA COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING

WHEREAS, the City of Hastings is a participating jurisdiction with the Dakota County Community Development Block Grant (CDBG) Entitlement Program for Fiscal Year 2020 (ending June 30, 2021); and

WHEREAS, the Dakota County Community Development Agency (CDA) is a Subgrantee of Dakota County for the administration of the CDBG Program; and

WHEREAS, the Dakota County CDA has requested Fiscal Year 2018 CDBG applications be submitted by January 17, 2020, based on an allocation of funds approved in the Annual Action Plan.

NOW, THEREFORE, BE IT RESOLVED that the City of Hastings hereby approves the following:

- 1. The Fiscal Year 2020 CDBG application is approved for submission to the Dakota County CDA.
- 2. The City Administrator for the City of Hastings is authorized to execute the application and all agreements and documents related to receiving and using the awarded CDBG funds.
- 3. The Dakota County CDA is designated as the administrative entity to carry out the CDBG program on behalf of the City, subject to future Subrecipient Agreements that may be required for specific CDBG-funded activities.
