**Council Action Requested:**

Adopt the attached resolution approving a Fireworks Tent License for TNT Fireworks in the Walmart parking lot.

**Background Information:**

Virginia Hightower, Permitting Coordinator of TNT Fireworks, submitted the appropriate documents for a Fireworks Tent License to be located in the Walmart parking lot, 1752 Frontage Road. Ms. Hightower has passed the background check conducted by Hastings Police Department. The Hastings Fire Inspector reviewed the documents and had no comments.

The proposed dates of sale are June 19, 2020 through July 6, 2020. The tent will be raised approximately three days prior to the sale and removed within five days of the completion of the sale. Hours of operation will be from 8:00am to 10:00pm.

Approval and issuance of the license is contingent on final inspection of the tent by Hastings Fire Inspector.
