Adopt the attached resolution approving a Massage Establishment License for Prime Chiropractic.

**Background Information:**

Hannah Pick, Prime Chiropractic, 1806 Vermillion Street, Suite A, completed the necessary paperwork and passed the background check conducted by Hastings Police Department and passed the Hastings Fire Inspector inspection for a Massage Establishment License. Prime Chiropractic is active and in good standing with the Office of the Minnesota Secretary of State.

Notification of Prime Chiropractic's application as a Massage Establishment was mailed to all property owners, businesses and residents surrounding the location. As to date, no comments have been received.

Current COVID-19 Pandemic Emergency Executive Orders prohibit massage therapy services from being offered at this time. Ms. Pick is aware that no massage services can be offered unless and until the Emergency Executive Orders expire, are rescinded or modified to allow massage services to resume.

The Massage Establishment license is a three-year period. The current licensing period is January 1, 2020 through December 31, 2022.
