- 11 month service project funded by AmeriCorps and facilitated by MPCA




### **RECYCLING TASKS**

# **OBSERVATIONS AND RECOMMENDATIONS**

- Residents want to become more sustainable
- Local groups would benefit from a contact point.
- Dakota County Ordinance 110
- In Dakota County, there are 5 positions within cities devoted recycling and other sustainability efforts. In Ramsey county there are 11 (including 4 in Saint Paul.) Hennepin County has 21(including 7in Minneapolis.)
- I'd recommend when feasible, adding an environmental specialist position to work on recycling, energy, outreach, and sustainability efforts for the city.
