Commissioner Karnick motioned to approve minutes, Commissioner Pemble seconded the motion. Minutes approved 5:5

- IV. People Movement Plan 7:05 p.m.
Director Jenkins provided a summary of strategies from the People Movement Plan. Jenkins noted the plan is in the final stage and staff requests Commission to offer a recommendation that will be provided to City Council. Commissioners asked questions regarding the People Movement Plan. Jenkins clarified the People Movement Plan is a document to be used in conjunction with other City planning documents and to use as a guide. Commissioner Pemble motioned to approve the People Movement Plan. Commissioner Santelman seconded the motion. Motion approved 5:5
- V. Department Updates 7:45 p.m.
Jenkins highlighted Department updates including:
- Call for Commissioners, interviews will take place prior to the next PRC meeting
 - Ice Fishing program attendance last weekend included 43 households who registered for timeslots, upcoming programs include: Ice Fishing at Lake Rebecca, Saturday, February 13th, Snowshoe Guided Hikes at Jaycee Park, Sunday, February 14th and Saturday, February 27th & registration is required by contacting pmarschall@hastingsmn.gov
 - The Civic Arena is operating within current guidelines
 - Park Maintenance Staff are working on building ice at outdoor rinks, warming houses will open once the hiring process is complete. Current capacity restrictions will apply
 - Next steps for the Lake Isabel Master Plan is to bring to the Committee of Council
 - Staff is applying to the DNR outdoor recreation grant
