Response to City Administrator denial of an Arts and Culture Commission Proposal

1. In response to statement number one:

There can be two tracts for the "Hastings is Arts" plan. The 2040 Comprehensive Plan is one tract and is used by developers. It does not need to be included in the 2040 Comprehensive plan but could be added as an appendix. The "Hastings is Arts" Plan could be used as a working plan should the Hastings Arts and Culture Commission (A & C Commission) be codified.

- 2. The request to consider a Hastings Arts and Culture Commission was formed through interested residents and community supporters.
- Per Wendy Wulff and Patrick Boylan (representatives for Hastings on the Met Council) the Met Council does not review elements of a cities 2040 Comprehensive Plan that are outside of its' purview – i.e. regional systems (sewer lines) and regional policies (transportation). Many cities include elements outside of these prescribed areas.
- 4. Within city budget discussions there are strains on resources, staff and budget. The budget reflects the priority of the community. An Arts and Culture Commission would support many of the areas that have been identified as strategic priority initiatives including making Hastings more inclusive, tourism, and economic development. An Arts and Culture Commission can help to achieve these strategic initiatives.
- 5. It is unclear what this proposal is referencing. It appears to come from the Hastings is Arts plan. Goals, objectives and strategies are simply road maps and do not commit staff to anything. The Hastings is Arts plan is just that – a plan. The plan would be used by an A & C Commission as a roadmap.
- 6. The City of Hastings has 5 commissions. They are the Charter Commission, Planning Commission, lead by John Hinzman, The Parks and Recreation Commission, led by Chris Jenkins, the Public Safety Advisory Commission led by Chief Schaffer and Chief Townsend and the Heritage Preservation Commission where Justin Forney acts as staff liaison. Some of these commissions are statutorily required. Commissions that are not statutory were formed to benefit the residents of Hastings. These non statutory commissions contribute our quality of life in Hastings.
- It is unclear what proposal is being addressed. The assumption is that the reference is to the draft Ordinance. Some Council members have expressed interest as acting as a liaison to an Arts and Culture Commission. The council member would serve as a contact point if needed or warranted.

- 8. It is unclear what proposal is being addressed. The assumption is that the reference is to the draft Ordinance. The staff time commitment to the A & C Commission will be minimal. At this point, there are no budgetary considerations to be made. There are multiple funding sources outside of the city budget that could be accessed by the A & C Commission.
- 9. It is unclear what proposal is being addressed. It is assumed that the reference is to the draft ordinance. It is unclear what operational role is being addressed. As stated above, no budgetary request is being made for the A & C Commission.
- 10. References to an "arts task force" and "initiatives" imply a specific project with a completion date. The A & C Commission would be an ongoing entity providing continuity and commitment to arts and culture in Hastings.
