**Operation of Motorized Golf Cart and  
4-Wheel All-Terrain Vehicles on City Streets**

Any permit issued may be revoked by the City Council at any time if evidence is presented to the City Council that the permitted cannot safely operate the motorized golf cart or 4-wheel all-terrain vehicle on the designated streets or if the insurance required by City Ordinance is terminated for any reason. Before any permit can be revoked by the City Council the permitted shall be given notice of the Council Meeting where the permit will be discussed. At that Council Meeting the permitted will be given an opportunity to address the Council.

**Data Practices Notice**
